## RESOLUTION NO. 04-58

WHEREAS, the Bonner County Board of Commissioners of Bonner County, Idaho received a Petition for the creation of an ambulance district in accordance with Title 31, Chapter 39 of Idaho Code, and;

WHEREAS, legal notice was published and public hearings were held as required by Idaho Code §31-3908(1)(d), and;

WHEREAS, Idaho Code §31-3908 empowers the Board of County Commissioners of Bonner County to create an ambulance district wherein the legislature has determined and found that ambulance service is a governmental function, and;

WHEREAS, Idaho Code §31-828 provides that counties shall have the power to do and perform all acts and things required by law which may be necessary to fulfill and discharge the duties of the chief executive authority of Bonner County government, and;

WHEREAS, a crisis situation has developed in Bonner County because of the lack of ambulance service in Bonner County, Idaho, and; Idaho Code §31-3908(4) allows the Board of County Commissioners of Bonner County, Idaho to levy a special tax not to exceed .04 percent of market value for all taxable property within a district for the purposes of the district, and;

WHEREAS, Idaho Code §31-3908(3) established the Board of County Commissioners upon the creation of an ambulance district shall be the governing board of said district and shall exercise the duties and responsibilities associated therewith.

NOW, THEREFORE, IT IS HEREBY RESOLVED that in accordance with Title 31, Chapter 39 of Idaho Code the Bonner County Board of Commissioners hereby creates the Bonner County ambulance service district and the boundaries of said district are that of the corporate boundaries of Bonner County, Idaho.

**FURTHER, IT IS HEREBY RESOLVED** that the levy rate for this special tax is .04 percent of the market value for all taxable property within the district which is and includes the corporate boundaries of Bonner County, Idaho.

FURTHER, IT IS HEREBY RESOLVED in accordance with Idaho Code §31-3908(3) that the Bonner County Board of Commissioners is the governing board of this ambulance service district.

**FURTHER, IT IS HEREBY RESOLVED** that the sponsors of the Petition for creation of the ambulance service district shall be reimbursed the fees expended by them for the cost associated with the publication of the notices necessary in hearing the Petition.

FURTHER, IT IS HEREBY RESOLVED that a copy of this Resolution be filed with the Bonner County Clerk and Recorder in accordance with Idaho Code §31-3908(e).
