 - -Sandpoint: Done with summer operations, poised for winter, Jeff back on full duty, experimental delineators
 - -Priest River: Can't remove snow between hangers once inhabited, discussion of what is needed in order to accomplish this task, interest in buildings that need to be removed in the airport protection zone, discussion of fuel a the Priest River airport
- 4. Airport Manager's Report -Dave Schuck
 - Priest River: Finished obstruction removal on approach to runway #1, project went well, over a three year period, replacement trees also complete, similar project starting at the North end, terrain is a little more challenging, leased all lots that are acceptable, more requests for leasable land, master plan-development, two shelters up for lease, currently in the bid process, 11 people interested, working with engineers, Corrie with T-O Engineers spoke in regards to updating EA and runway rehabilitation including runway end lights and renaming of the runway -Sandpoint: Land acquisition and easements, runway protection zones, \$400,000 toward payment rehabilitation-get us through until runway rebuild (2023-2024), rehabilitation will include patching, striping, sealing, etc., Westside Taxiway discussion, leased almost all developed property available, what do we do for more hanger space?

 - One lease at Priest River, waiting to be signed, some executive row lots at Sandpoint
- 6. FAA and TTF Matters/Update Dave Schuck
 - Nothing really new, working with attorneys still on TTF matters
