EMS – Bob Bussey

- Discussion/Decision Regarding Unanticipated Revenue Budget Adjustment; \$20,000, **Resolution** Commissioner McDonald made a motion to approve Resolution No. 17-97 authorizing the adjustment of the Bonner County EMS budget to reflect the receipt of unanticipated grant funds in the amount of \$20,000.00 received from the Idaho EMS grant for the purchase of a Stryker power load system. This would increase FY2018 budget, line item 99918-9420 Capitol Equipment from \$0.00 to \$20,000.00. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- 2) Discussion/Decision Regarding Surplus of a Bonner County EMS Vehicle; **Resolution** Commissioner Connolly made a motion to approve Resolution 17-98 declaring the listed vehicle as surplus to be sold at a county auction at a later date. Commissioner McDonald seconded the motion. All in favor. The motion passed.
