MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

December 10, 2019 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, December 10, 2019 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Connolly, McDonald & Bradshaw present, and Chairman Connolly called the meeting to order at 9:00 a.m. The Invocation was presented by Jon Pomeroy and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to add an Executive Session under Idaho Code 74-206 (1) (D) Records Exempt. Commissioner McDonald seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw made a motion to adopt the order of agenda as amended. Commissioner McDonald seconded the motion. All in favor. The motion passed.

SHERIFF'S OFFICE - Daryl Wheeler (Ror Lakewold Presented)

 Action Item: Discussion/Decision Regarding Memorandum of Agreement with FEMA IPAWS Public Notification System Commissioner Bradshaw made a motion to approve the Chairman signing the MOA between Bonner County and the FEMA IPAWS Program, along with any additional ancillary documents. Commissioner McDonald seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding North Idaho Crisis Services Agreement; \$10,000.00 Commissioner McDonald made a motion to approve the agreement between Bonner County and North Idaho Crisis Services to provide after-hours crisis counselling, evaluation and transportation services. The County will reimburse NICS \$10,000 per year. This agreement is a renewal that will be effective from October 1, 2019 to September 30, 2020, unless terminated earlier upon 30 days' notice from either party. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

AIRPORT - Dave Schuck

1) Action Item: Discussion/Decision Regarding Grant Acceptance from ITD Division of Aeronautics for Sandpoint Airport; Resolution

Commissioner Bradshaw made a motion to approve Resolution #19-113 accepting this grant offer in the amount of \$40,632.11 from the ITD Division of Aeronautics for the Sandpoint Airport and that the Chairman sign the acceptance administratively. Commissioner McDonald seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding Grant Acceptance from ITD Division of Aeronautics for Priest River Airport: Resolution

Commissioner McDonald made a motion to approve Resolution #19-114 accepting this grant offer in the amount of \$21,934.94 and that the Chairman sign the acceptance administratively. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

- 4) Action Item: Discussion/Decision Regarding Land Purchase, Priest River, AIP Grant; \$4,150.00 Commissioner McDonald made a motion to enter into this purchase agreement for the described land at Priest River Airport and that the Chairman sign administratively. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
- 5) Action Item: Discussion/Decision Regarding Land Purchase, Sandpoint, AIP Grant; \$9,840.00 Commissioner Bradshaw made a motion to enter into this purchase agreement for the described land near Sandpoint Airport and that the Chairman sign administratively. Commissioner McDonald seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Unanticipated Revenue, Bonner Soil & Water Conservation District; **Resolution**

Commissioner McDonald made a motion to approve Resolution #19-115, authorizing the Clerk to open the Road & Bridge FY2019 budget and schedule revenue by increasing accounts 002-8490 Plant Mix Asphalt by \$132,796.00 as detailed in the Resolution. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

SOLID WASTE – Bob Howard

1) Action Item: Discussion/Decision Regarding Acceptance of Metal Pile Removal Bid from Pacific Steel Commissioner Bradshaw made a motion to award Pacific Steel and Recycling the contract for the processing and removal of the metal piles at the Idaho Hill, Dickensheet and Colburn sites. Pacific Steel and Recycling has agreed to pay Bonner County \$57.00 per ton. Commissioner McDonald seconded the motion. All in favor. The motion passed.

EMERGENCY MANAGEMENT – Bob Howard
