# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

March 24, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, March 24, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Bradshaw & Connolly present, and Chairman McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Commissioner Bradshaw and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to adopt the order of agenda as Amended. Commissioner Connolly seconded the motion. All in favor. The motion passed.

- 3) Action Item: Discussion/Decision Regarding Vehicle Purchase; \$27,187.00 Commissioner Connolly made a motion to approve the payment for \$27,187.00 to Pierce Auto Center for the purchase of a 2020 Dodge Ram 1500. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
