# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

May 26, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, May 26, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present, and Chairman McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Bob Howard and the Pledge of Allegiance followed.

### ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to remove EMS Item #1 Action Item: Discussion/Decision Regarding Lease/Contract Columbia Bank, Ambulance purchase AND Add Emergency Management Item #1 Declaration of Local Disaster Emergency, Flooding; **Resolution** 

Commissioner Connolly made a motion to adopt the order of agenda as amended. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

**PUBLIC COMMENT** – Susan Drumheller spoke in regards to the Planning item regarding flood insurance. Dan Rose spoke in regards to a PRR and county attorneys, submitted a document for the record.

# CONSENT AGENDA - Action Item

Bonner County Commissioners' Minutes for May 19, 2020
 Commissioner Bradshaw made a motion to approve the Consent Agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

# PLANNING - Milton Ollerton

- 1) Action Item: Discussion/Decision Regarding AM0008-20 Title 11 Amendment Commissioner Connolly made a motion to approve Ordinance (# to be assigned) amending Bonner County Revised Code, Title 11 Section 105 (B) as presented. Commissioner Bradshaw seconded the motion. Roll Call Vote: Commissioner McDonald Aye, Commissioner Connolly Aye, Commissioner Bradshaw Aye. All in favor. The motion passed.
- 2) Action Item: Discussion/Decision Regarding Formation of Title 11 Building Regulations Committee Commissioner Bradshaw made a motion to authorize the Planning Department to advertise and begin the process for the Board to appoint a Building Regulations committee to assist in reviewing and updating Title 11. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- Action Item: Discussion/Decision Regarding County Withdrawal, National Flood Insurance Program, Community Rating System

Commissioner Connolly made a motion to instruct staff to begin the process to withdraw Bonner County from the voluntary National Flood Insurance Program Community Rating System (NFIP-CRS), with the intent to restore local control over zoning and density to Bonner County. I further move to grant authority to the Chair of the Board

to sign the required official CRS withdrawal letter of intent, which will be generated by staff. I further move to instruct staff to mail this signed CRS withdrawal letter to Marlene Jacobs, CFM, Senior Floodplain Specialist with Verisk Analytics, to complete the process to officially withdraw Bonner County from the voluntary NFIP-CRS program. This action does not result in a taking of private property. There were comments from the public regarding density and development. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

#### **RECREATION** – Nate Demmons

 Action Item: Discussion/Decision Regarding Idaho Department of Lands Land Use Permit No. LU200042, Hayes Gulch

Commissioner Bradshaw made a motion to approve and sign administratively the Idaho Department of Lands Use Permit No. LU200042 that will allow Bonner County to maintain facilities, improvements, and trails on Idaho State Lands in Hayes Gulch. Commissioner Connolly seconded the motion. All in favor. The motion passed.

# SHERIFF'S OFFICE - Daryl Wheeler

1) Action Item: Discussion/Decision Regarding Immigration and Customs Enforcement (ICE) Detention Management/Detention Contract

Commissioner Connolly made a motion to approve the agreement between ICE and Bonner County for the Sheriff's Office to provide detention and maintenance of ICE Detainees. ICE will reimburse Bonner County up to \$686.00 at a rate of \$98.00 per day per inmate between June 1, 2020 and May 31, 2021. Thereafter, there are four potential yearly Option Periods of performance. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

#### ROAD & BRIDGE - Steve Klatt

- 1) Action Item: Discussion/Decision Regarding Curtis Creek Sand, Southwest District 1; \$4.50/ton Commissioner Bradshaw made a motion to approve the purchase of sand from Curtis Creek Sand & Gravel to service the southwest roads of District 1. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- Action Item: Discussion/Decision Regarding Adams Road Overlay, Priest Lake; \$13,910.00 Commissioner Connolly made a motion to accept the bid of Wood's Crushing & Hauling for \$13,910 to apply a 1-1/2 inch asphalt overlay to repair Adams Road, concluding our service to this road. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

# **HUMAN RESOURCES** – Cindy Binkerd

1) Action Item: Discussion/Decision Regarding Pre Hire Onboarding Practices Policy #200 Revision Commissioner Bradshaw made a motion to approve changes to Policy #200, Pre Hire and Onboarding to the Bonner County Personnel Policy Manual, effective May 26, 2020. Commissioner Connolly seconded the motion. Sheriff Wheeler commented on this policy change. All in favor. The motion passed.

Commissioner Connolly made a motion to approve and ratify Resolution #20- 35 and declare that a local disaster emergency exists in Bonner County, Idaho due to snow melt, warming temperatures and rain resulting in flooding. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
