MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

June 23, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, June 23, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present, and Chairman McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Jerry Favor and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of the agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Letter of Support, Southside Sewer & Water, Water Quality Investigation

2) Action Item: Discussion/Decision Regarding Vacation of a Right-Of-Way, File #VS0005-19; **Resolution** Commissioner Bradshaw made a motion to approve Resolution # 2020-42 vacating a Right of Way in a portion of Section 4, Township 55 North, Range 4 West, Boise Meridian, Bonner County, Idaho and conveying the vacated area to Brian Ringe, Ringe Properties LLC. Commissioner Connolly seconded the motion. All in favor. The motion passed.

PUBLIC DEFENDER – Janet Whitney

1) Action Item: Discussion/Decision Regarding Destruction of Records; **Resolution**Commissioner Connolly made a motion to approve Resolution #2020-43 authorizing the Public Defender's Office to destroy the documents as listed in the attached Resolution and as outlined in the Public Defender's Records Retention Policy Resolution #16-22. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

RECREATION – Nate Demmons

1) Action Item: Discussion/Decision Regarding Unanticipated Revenue; **Resolution**Commissioner Bradshaw made a motion to approve Resolution #2020-44 authorizing the Clerk to open the Parks budget and increase line item 030-7860 Miscellaneous Expenses in the amount of \$1,580.17. Commissioner Connolly seconded the motion. All in favor. The motion passed.

ROAD & BRIDGE - Steve Klatt

1) Action Item: Discussion/Decision Regarding District 3 Shop Addition, Low Bid Acceptance & Contract; \$159,558.00

Commissioner Connolly made a motion to accept the low bid of Onyx Construction Management, LLC for \$159,558.00 and sign the contract for the construction of the D3 Shop Addition. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw made a motion to approve the contract with Bestway Tree Service to remove the trees necessary for road improvements to Woodland Drive for a 'not to exceed' amount of \$20,000.00 Commissioner Connolly seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Idaho Department of Parks and Recreation Grant Agreement Commissioner Connolly made a motion to approve and sign the agreement between IDPR and Bonner County to accept WIF grant monies to acquire and install two FLIR devices on Sheriff vessels. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
