1) Action Item: Discussion/Decision Regarding Jail "A" to Jail "B" Fund Transfer; **Resolution** Commissioner Connolly made a motion to approve Resolution #2020-54 authorizing the Clerk to open the Jail "A" budget and transfer from 03478-6020 Salaries to "B" budget and increase line item 03461-9420 — Capital-Equipment by \$34,512.57. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

On Tuesday, July 21, 2020, Thursday, July 23, 2020, Friday, July 24, 2020 & Monday, July 27, 2020 Budget Workshops were held pursuant to Idaho Code §74-204(2).

On Wednesday, July 22, 2020 a Planning Hearing was held pursuant to Idaho Code §74-204(2). Commissioner Connolly made a motion to approve this project, FILE AM0004-20, requesting a comprehensive plan amendment from Ag/Forest (10-20 AC) & Rural Residential to Transition, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law as written (or as amended). This action does not result in a taking of private property. Commissioner Bradshaw seconded the motion. All in favor. The motion passed. Commissioner Connolly made a motion to approve resolution #20-52 amending the Bonner County Projected Land Use Map. Commissioner Bradshaw seconded the motion. All in favor. The motion passed. Commissioner Connolly made a motion to approve this project, FILE ZC0004-20, requesting a zone change from Ag/Forest 10 & Rural Service Center to Commercial, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to

adopt the following findings of fact and conclusions of law as written (or as amended). This action does not result in a taking of private property. Commissioner Bradshaw seconded the motion. All in favor. The motion passed. Commissioner Connolly made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of the Official Zoning Map of Bonner County by the reclassification of lands located in Section 4, Township 57 North, Range 1 West, Boise Meridian, Bonner County, Idaho from Agriculture Forestry-10 & Rural Service Center to Commercial, and providing for an effective date. I further move to authorize the Chair to sign the official supplementary zoning map upon publication of the ordinance. Commissioner Bradshaw seconded the motion. Roll call vote - Commissioner McDonald - Aye, Commissioner Connolly - aye, Commissioner Bradshaw - Aye All in favor. The motion passed. Commissioner Bradshaw made a motion to approve this FILE AM0006-20, to amend the sections of Title 12, Bonner County Revised Code, as presented or amended in this hearing, based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law. This action does not result in a taking of private property. Commissioner Connolly seconded the motion. All in favor. The motion passed. Commissioner Bradshaw made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of Title 12, Bonner County Revised Code, as presented or amended in this hearing, and providing for an effective date. Commissioner Connolly seconded the motion. Roll call vote - Commissioner McDonald - Aye, Commissioner -Connolly - Aye, Commissioner Bradshaw - Aye. All in favor. The motion passed.

On Thursday, July 23, 2020 a Budget Workshop for Technology was held pursuant to Idaho Code §74-204(2) followed by an Executive Session pursuant to Idaho Code §74-206(1)(D) Records Exempt.

On Friday, July 24, 2020 a Facilities Workshop was held pursuant to Idaho Code §74-204(2).

On Friday, July 24, 2020 a Visit from the Spokane County Chief Operating Officer was held pursuant to Idaho Code §74-204(2).
