MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

September 1, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, September 1, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present, and Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Ken Lawrence and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to adopt the order of the agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

Action Item: Discussion/Decision Regarding Medical Director Agreement with Dr. Ronald Jenkins;
 \$45,360.00

Commissioner Connolly made a motion to approve and sign the Medical Director Agreement between Dr. Ronald Jenkins and Bonner County EMS for the 2021 fiscal year. This contract commences October 1, 2020 and will remain effective for one year. The cost of this contract is \$45,360.00 which will be paid in monthly installments of \$3,780.00. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

FAIR - Darcey Smith

1) Action Item: Discussion/Decision Regarding Bid Award, Campground Road Improvements

Commissioner Bradshaw made a motion to award the Fairgrounds Campgrounds Road Reconstruction and Improvements Project to Interstate Concrete & Asphalt for the amount of \$152,867.50 and allow the Chairman to sign the contract. - 2) Action Item: Discussion/Decision Regarding Budget Transfer, Object Line Funds; **Resolution** Commissioner Connolly made a motion to approve Resolution #2020-63, authorizing the Clerk to open the Road and Bridge FY2020 budget and transfer revenue from 002-7430 and 8510 to 002-9000, 9370, and 9520 as detailed in the Resolution. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
- 3) Action Item: Discussion/Decision Regarding Purchase of Grader Bits; \$39,066.00 Commissioner Bradshaw made a motion to authorize the Road & Bridge Department to purchase \$39,066.00 of bits for winter plowing from Rebuilding & Hardfacing, Inc. Commissioner Connolly seconded the motion. All in favor. The motion passed.
