MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

September 15, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, September 15, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald & Bradshaw present, and Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Jon Pomeroy and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to adopt the order of the agenda as presented. Commissioner McDonald stepped down from the Chair and seconded the motion. All in favor. The motion passed.

PUBLIC COMMENT – Members of the Selle Valley Sub-Committee:

Fred Omodt – Spoke in regards to the Selle Valley Sub-Committees work and a recent P&Z meeting where their document was discussed.

Susan Fey – Spoke as official record keeper of the committee, and discussed documentation (Maps) that were allegedly changed by Planning (and distributed)

Betty Anderson – Spoke regarding the Selle Valley Committee formation. Also spoke of their good faith efforts to create a plan for the Selle Valley committee and the efforts of P&Z to undermine their work.

Brian Wood – Spoke in regards to the time it took to produce the Selle Valley plan, discussed the maps placed in the plan that are allegedly wrong, has concerns over the document being altered.

Diane Wheeler – Discussed her experience on the Selle Valley Subcommittee, accusing various County officials of not doing their jobs and altering documents.

Charles Pope – Discussed changes to the county mapping in the Selle Valley area (lime green). Also discussed changes in documents within their version of the plan. Spoke in regards to the legal turmoil he perceives to be plaguing the planning department.

Commissioner Connolly moved to approve this project, FILE ZC0007-20, requesting a Zone Change from Ag/Forest-10 to R-5, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to recommend the following findings of fact and conclusions of law as written (or as amended). This action does not result in a taking of private property. Commissioner Bradshaw seconded the motion, All in favor. The motion passed. Commissioner Bradshaw moved to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of the Official Zoning Map of Bonner County by the reclassification of lands from Ag/Forest-10 to R-5, providing for an effective date. I further move to authorize the Chair to sign the official supplementary zoning map upon publication of the ordinance. Commissioner Connolly seconded the motion. Roll-call Vote: Commissioner McDonald -aye, Commissioner Connolly - aye, Commissioner Bradshaw -aye, All in favor. The motion passed. Commissioner Bradshaw made a motion to approve this project, FILE ZC0008-20, requesting a zone change from Rural - 5 to Recreation, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law as written (or as amended). This action does not result in a taking of private property. Commissioner Connolly seconded the motion. All in favor. The motion passed. Commissioner Connolly made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of the Official Zoning Map of Bonner County by the reclassification of lands located in Section 12, Township 56 North, Range 1 East. Boise Meridian, Bonner County, Idaho from Rural - 5 to Recreation, and providing for an effective date. I further move to authorize the Chair to sign the official supplementary zoning map upon publication of the ordinance. Commissioner Bradshaw seconded the motion. Roll-call vote: Commissioner McDonald -aye, Commissioner Bradshaw – aye, Commissioner Connolly –aye. All in favor. The motion passed.
