# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

September 22, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, September 22, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present, and Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Dan York and the Pledge of Allegiance followed.

Commissioner Connolly made a motion to approve the Bonner County MOA to Support the CBAS Program and the SUDS Program. This agreement provides state funding for the 2020-2021 fiscal year for approved treatment programs for juvenile offenders and has been previously approved by legal. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

#### EMERGENCY MANAGEMENT - Bob Howard (Commissioner Connolly Presented)

1) Action Item: Discussion/Decision Regarding Memorandum of Understanding between Bonner County and Idaho Department of Lands

Commissioner Bradshaw made a motion to approve the Memorandum of Understanding Grant# 16HFR1-Bonner in the amount of \$55,000.00 and allow the chair to sign. Commissioner Connolly seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding Contract, Inland Forest Management Commissioner Connolly made a motion to approve and sign the Professional Services Contract between Bonner County and Inland Forest Management for the amount of \$9,900.00. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

- 1) Action Item: Discussion/Decision Regarding Assignment, Lot 4 Lease, Sandpoint Airport Commissioner Bradshaw made a motion to accept this lease assignment for Lot 4 at Sandpoint Airport and that the Chairman sign administratively. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- 2) Action Item: Discussion/Decision Regarding Assignment, Lot 2 Lease, Sandpoint Airport Commissioner Connolly made a motion to accept this lease assignment for Lot 2 at Sandpoint Airport and that the Chairman sign administratively. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

#### SHERIFF'S OFFICE - Daryl Wheeler

1) Action Item: Discussion/Decision Regarding City of Oldtown, Law Enforcement and Prosecution Services Agreement

Commissioner Connolly made a motion to approve the agreement between the City of Oldtown and Bonner County to provide law enforcement and prosecution services. The City will reimburse Bonner County \$100 per month. The agreement will be effective from October 1, 2020 to October 1, 2022, unless terminated earlier upon 90 days' notice from either party. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding City of Dover, Law Enforcement and Prosecution Services Agreement

Commissioner Bradshaw made a motion to approve the agreement between the City of Dover and Bonner County to provide law enforcement and prosecution services. The City will reimburse Bonner County \$100 per month. The agreement will be effective from October 1, 2020 to October 1, 2022, unless terminated earlier upon 90 days' notice from either party. Commissioner Connolly seconded the motion. All in favor. The motion passed.

3) Action Item: Discussion/Decision Regarding Subleasing Space at Communication Site to Government Agency

Commissioner Connolly made a motion to approve the request authorizing the Bonner County Sheriff's Office to sublease the space at a communication site to another agency and sign the contract administratively. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
