MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

November 10, 2020 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, November 10, 2020 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Connolly & Bradshaw present, and Commissioner McDonald is absent. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Jon Pomeroy and the Pledge of Allegiance followed.

1) Action Item: Discussion/Decision Regarding Kootenai Tribe of Idaho, Inmate Housing Agreement Commissioner Connolly made a motion to approve the Adult Detention Agreement between the Kootenai Tribe of Idaho and Bonner County to house male and female inmates at the Bonner County detention facility. The Tribe will reimburse Bonner County \$90 per day per inmate with the agreement being effective from date of execution until November 30, 2021. Commissioner Bradshaw stepped down from the Chair and seconded the motion. All in favor. The motion passed.

ROAD & BRIDGE - Steve Klatt
