Commissioner Bradshaw seconded the motion. All in favor.

2) Action Item: Discussion/Decision Regarding Heavy Trucks (3) Purchase Order, DEQ VW Rebate Agreement

Commissioner Bradshaw made a motion to approve the Vehicle Purchase Agreements from Freightliner Northwest for the trucks approved in the DEQ VW Settlement Rebate Agreement to reduce the cost of replacing three old trucks with three new Western Star 4700 trucks by a 40% rebate of \$230,099.00. Commissioner Connolly seconded the motion. All in favor. The motion passed.
