Commissioner Bradshaw made a motion to approve Resolution #2021-08 the destruction of Bonner County Juvenile Detention facility "temporary records", as described above, held by the Bonner County Juvenile Detention Center for the year 2018, pursuant to Idaho Code Setion 31-871 (c), as approved by legal. Commissioner Connolly seconded the motion. All in favor. The motion passed.

3) Action Item: Discussion/Decision Regarding Records Destruction, Incident Report Records – Years 1998-2009; Resolution

Commissioner Connolly made a motion to approve Resolution #2021-09 the destruction of Bonner County Juvenile Detention facility "permanent records", as described above, held by the Bonner County Juvenile Detention Center for the years 1998 to 2009, pursuant to Idaho Code Section 31-871 (c), as approved by legal. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

- 4) Action Item: Discussion/Decision Regarding Unanticipated Revenue, Lottery Tax; **Resolution**Commissioner Bradshaw made a motion to approve Resolution #2021-10 ordering the Clerk to schedule revenue in the Probation Services FY2021 budget, Account No. 006-00661-9500 Capital Office Equipment by \$23,759.00 from \$0 to \$23,759.00. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- 5) Action Item: Discussion/Decision Regarding Unanticipated Revenue, Cigarette Tax; **Resolution**Commissioner Connolly made a motion to approve Resolution #2021-11 ordering the Clerk to schedule revenue in the Probation Services FY2021 budget, Account No. 006-00661-7900 Cigarette Tax Carryover by \$105,088.00 from \$30,000.00 to \$135,088.00. This adjustment is due to the receipt of unanticipated Tobacco Tax revenue received from the State of Idaho. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
- 6) Action Item: Discussion/Decision Regarding Unanticipated Revenue, Detention Contracts; **Resolution** Commissioner Bradshaw made a motion to approve Resolution #2021-12 ordering the Clerk to schedule revenue in the Juvenile Detention FY2021 budget, Revenue Account No. 034-03475-4990 JUVENILE DETENTION BILLING for use as additional funding for Juvenile Detention FY2021 Budget, Account No. 034-75-7430 REPAIRS & MAINTENANCE BUILDINGS/FIXTURES/GROUNDS in the amount of \$25,083.00. This adjustment is due to the receipt of unanticipated revenue received from parent billings and contracts for housing juvenile offenders in the Bonner County Juvenile Detention Center. Commissioner Connolly seconded the motion. All in favor. The motion passed.
