# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

February 23, 2021 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, February 23, 2021 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Bradshaw & Connolly present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Angel Rodriguez and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA
