May 11, 2021 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, May 11, 2021 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Bradshaw & Connolly present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by John Pomeroy and the Pledge of Allegiance followed.

Commissioner Bradshaw made a motion to adopt the order of the agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

winter trail maintenance Resource Advisory Council award. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

4) Action Item: Discussion/Decision Regarding Resource Advisory Committee Grant Proposal, Gold Hill Overflow Parking; \$4,000.00 Match

Commissioner Bradshaw made a motion to approve and sign the application for the Gold Hill Overflow Parking Proposal. By signing, a final agreement between Bonner County and the Forest Service will be awarded in the amount of \$31,752.00 with a \$4,000.00 in kind match. Commissioner Connolly seconded the motion. All in favor. The motion passed.

ROAD & BRIDGE – Steve Klatt

- 1) Action Item: Discussion/Decision Regarding Purchase, Walk-n-Roll Compactor; \$22,900.00 Commissioner Connolly made a motion to approve the purchase of a Walk-n-Roll compactor for \$22,900 and to authorize the Chairman to accept & sign the Pape Machinery quote summary administratively. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
- 2) Action Item: Discussion/Decision Regarding District 2 Shop Roof, Bid Package and Design; \$7,200.00 Commissioner Bradshaw made a motion to approve the Proposal and Agreement with H2A Architects for \$7,200.00 to assist with design specs, bid package and contracting of 13,000 square feet of the District 2 shop roof overlay and the Chairman to sign administratively. Road & Bridge is authorized to advertise for bids according to Idaho Code. Commissioner Connolly seconded the motion. All in favor. The motion passed.

On Wednesday, April 28, 2021 a Wildlife Services Update was held pursuant to Idaho Code §74-204 (2).

On Wednesday, April 28, 2021 a Planning Hearing was held pursuant to Idaho Code §74-204 (2). Commissioner Bradshaw made a motion to deny this project FILE AM0018-20, requesting a comprehensive plan amendment from AG/FOREST LAND to RURAL RESIDENTIAL, based upon the following conclusions: [REFER TO FOLLOWING CONCLUSIONS OF LAW AND SPECIFY WHICH CONCLUSIONS THE PROJECT MEETS AND FAILS TO MEET]. The decision is based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law as amended. This action does not result in a taking of private property. The action that could be taken, if any, to obtain the zone change is to: 1) File a new application with the Planning Department and meet the standards required by Bonner County Revised Code; or 2) Pursue such remedies as may be applicable at Title 67, Chapter 65, Idaho Code. The motion was not seconded, the motion does not pass. Commissioner Connolly made a motion to approve this project, FILE AM0018-20, requesting a comprehensive plan amendment from AG/FOREST LAND to RURAL RESIDENTIAL, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law as written. This action does not result in a taking of private property. Commissioner McDonald stepped down from the Chair and seconded the motion, Commissioner McDonald - aye. Commissioner Connolly - aye. Commissioner Bradshaw - nay. The motion passed. Commissioner Connolly read the Comprehensive Plan Amendment Findings of Fact into the record. Commissioner Connolly made a motion to approve resolution #2021-42 amending the Bonner County Projected Land Use Map. Commissioner McDonald stepped down from the Chair and seconded the motion. Commissioner Connolly made a motion to approve this project, FILE ZC0015-20, requesting a zone change from AGRICULTURAL/FORESTRY 10 (A/F-10) to RURAL-5 (R-5), finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the following findings of fact and conclusions of law as written. This action does not result in a taking of private property. Commissioner McDonald stepped down from the Chair and seconded the motion. Commissioner McDonald - aye. Commissioner Connolly ave. Commissioner Bradshaw – nay. The motion passed. Commissioner Connolly made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of the Official Zoning Map of Bonner County by the reclassification of lands located in Section 27, Township 55 North, Range 4 West, Boise Meridian, Bonner County, Idaho from Agricultural/Forestry 10 to Rural-5, and providing for an effective date. I further move to authorize the Chair to sign the official supplementary zoning map upon publication of the ordinance. Commissioner McDonald stepped down from the Chair and seconded the motion. Roll Call Vote: Commissioner McDonald – ave. Commissioner Connolly – ave. Commissioner Bradshaw - nay. The motion passed.
