MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

September 14, 2021 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, September 14, 2021 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Jon Pomeroy and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

- 1) Action Item: Discussion/Decision Regarding Medical Services Contract, Troy W Geyman. M.D. Commissioner Connolly made a motion to approve the Medical Services Contract between Troy W. Geyman, M.D. and the Bonner County Sheriff's Office. The amount of this contract will not exceed \$49,500 annually and is effective from September 30, 2021 to September 30, 2022. This agreement may be terminated by either party with 30 days' written notice. This contract is identical to the previous contract, except dates. Commissioner Bradshaw seconded the motion.
