# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

December 21, 2021 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, December 21, 2021 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Dan York and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Budget Adjustment, Unanticipated Revenue; **Resolution** Commissioner Bradshaw made a motion to approve Resolution #2021 - 122, authorizing the Clerk to open the Road and Bridge FY2022 budget and add unanticipated revenues to the Bonner County Road and Bridges "B" Budget for the sum of \$1,035,783.85 as detailed in the Resolution. Commissioner Connolly seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding MOU with City of Ponderay, Proposed Bike Path along McGhee Road

Commissioner Connolly made a motion to approve this memorandum of understanding between the City of Ponderay and Bonner County for the bike path along McGhee Road. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

3) Action Item: Discussion/Decision Regarding Professional Services Agreement, LHSIP Project Development, Right-Of-Way Clearing and Brushing

Commissioner Bradshaw made a motion to approve the professional services agreement #96080 with Century West Engineering, Inc. for a not to exceed amount of \$95,309.39. Commissioner Connolly seconded the motion. All in favor. The motion passed.
