### MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

January 18, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, January 18, 2022 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Jim Kubiak and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

Commissioner Connolly made a motion to approve Resolution #2022-4 ordering the Clerk to schedule revenue in the Probation Services FY21-22 budget, Account NO. 006-00661-7900 – Cigarette Tax Carryover by \$90,079.00 from \$30,000.00 to \$120,079.00. This adjustment is due to the receipt of unanticipated Tobacco Tax revenue received from the State of Idaho. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding Budget Adjustment, Lottery Tax Unanticipated Revenue;

Commissioner Bradshaw made a motion to approve Resolution #2022-5 ordering the Clerk to schedule revenue in the Probation Services FY21-22 budget, Account No. 006-00661-9390 - Capital - Vehicles by \$18,890 from \$23,759 to \$42,649.00. This adjustment is due to the receipt of unanticipated Lottery Tax revenue received from the State of Idaho. Commissioner Connolly seconded the motion. All in favor. The motion passed.

3) Action Item: Discussion/Decision Regarding Budget Adjustment, Detention Contracts Unanticipated Revenue: Resolution

Commissioner Connolly made a motion to approve Resolution #2022-6 ordering the Clerk to schedule revenue in the Juvenile Detention FY21-22 budget, Revenue Account NO. 034-03475-4990 – JUVENILE DETENTION BILLING for use as additional funding for Juvenile Detention FY21-22 Budget, Account NO. 034-03475-6110 – OVERTIME in the amount of \$5,000.00 and for use as additional funding for Juvenile Detention FY21-22 Budget, Account No. 034-03475-7430 – REPAIRS & MAINTENANCE BUILDINGS/FIXTURES/GROUNDS in the amount of \$34,474.50. This adjustment is due to the receipt of unanticipated revenue received from contracts for housing juvenile offenders in the Bonner County Juvenile Detention Center. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report (or as amended during this hearing) and direct planning staff to draft written findings and conclusions to reflect this motion, have the Chairman sign, and transmit to all interested parties. This action does not

result in a taking of private property. Commissioner Connolly seconded the motion. Roll Call Vote: Commissioner McDonald - Aye, Commissioner Connolly - Aye, Commissioner Bradshaw - Aye. All in favor. The motion passed. Commissioner Connolly made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of Title 12, Bonner County Revised Code, as presented or amended in this hearing, and providing for the effective date of this ordinance to be March 30, 2022 allowing for advertising and appointing the individuals to the Planning Commission and Zoning Commission. Commissioner Bradshaw made a motion to approve this project, FILE ZC0031-21, requesting a zone change Rural-10 to Rural-5 for the parcel noted in the staff report, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared, and testimony received at this hearing.
