MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

March 1, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, March 1, 2022 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Lydia Rasor and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to amend the agenda and add an Executive Session Under Idaho Code § 74-206 (1) (F) Litigation to discuss pending litigation – Action Item: Discussion/Decision Regarding Litigation. There has been a recent development in a pending case that requires the immediate attention of the board and the ability to discuss the matter with legal counsel to avert financial loss. It was not apparent that the executive session was needed until yesterday afternoon. Commissioner Connolly seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw made a motion to adopt the order of agenda as amended. Commissioner Connolly seconded the motion. All in favor. The motion passed.

Commissioner Connolly seconded the motion All in favor. The motion passed.

- Action Item: Discussion/Decision Regarding Solid Waste Improvements Project, Interim Loan Letter of Commitment

Commissioner Bradshaw made a motion to ratify the attached commitment letter provided by Columbia Bank and allow Bonner County Solid Waste to move forward in the process of obtaining an interim loan to be used for engineering and construction costs for the Solid Waste Improvements Project. Commissioner Connolly seconded the motion. All in favor. The motion passed.

Commissioner Connolly made a motion to approve this project, FILE ZC0037-21, requesting a zone change from Rural-10 to Rural-5, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report and direct planning staff to draft written findings and conclusions to reflect this motion, have Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property. Commissioner Bradshaw seconded the motion. Roll Call Vote: Commissioner McDonald - Aye. Commissioner Connolly - Aye. Commissioner Bradshaw - Aye. The motion passed. Commissioner Bradshaw made a motion to approve an Ordinance of Bonner County, Idaho, the number to be assigned, citing its authority, and providing for the amendment of the Official Zoning Map of Bonner County by the reclassification of lands located in Section 1, Township 55 North, Range 4 West, Boise Meridian, Bonner County, Idaho from Rural 10-acre to Rural 5-acre, and providing for an effective date. I further move to authorize the Chair to sign the official supplementary zoning map upon publication of the ordinance. Commissioner Connolly seconded the motion. Roll Call Vote: Commissioner McDonald - Aye. Commissioner Connolly - Aye. Commissioner Bradshaw - Aye. The motion passed. Commissioner Connolly made a motion to approve project FILE S0004-21, requesting platting of an approximately 14.75 acres of unplatted land, zoned Recreation, into 18 residential lots and 2 utility lots, located in Section 21, Township 56 North, Range 1 West, Boise Meridian, Bonner County, Bonner County, Idaho, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report and direct planning staff to draft written findings and conclusions to reflect this motion, have the Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property. The action that could be taken to obtain the preliminary plat is to complete the Conditions of Approval as adopted. Commissioner Bradshaw seconded the motion. Roll Call Vote: Commissioner McDonald - Aye. Commissioner Connolly - Aye. Commissioner Bradshaw – Aye. The motion passed.
