# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

March 29, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, March 29, 2022 the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Dan York and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw made a motion to approve the Consent Agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Budget Transfer, "A" to "B", Resolution Commissioner Connolly made a motion to approve Resolution #2022-22 transferring \$30,000.00 from the Clerk's budget 00101-6020 to 00101-7110. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

## ROAD & BRIDGE - Jason Topp

- 1) Action Item: Discussion/Decision Regarding Budge Adjustment, Unanticipated Revenue; Resolution Commissioner Bradshaw made a motion to approve Resolution 2022-23, authorizing the Clerk to open the Road and Bridge FY2022 budget and add unanticipated revenues to the Bonner County Road and Bridges Budget as detailed in the Resolution. Commissioner Connolly seconded the motion. All in favor. The motion passed.
- Action Item: Discussion/Decision Regarding Memorandum of Understanding, Hauling on a 700-foot Portion of Samuels Road, Samuels Storage LLC

Commissioner Connolly made a motion to approve this memorandum of understanding between the Samuels Storage, LLC and Bonner County Road and Bridge to allow all-weather hauling on this 700 foot portion of Samuels Road beginning at Highway 95. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

2) Action Item: Discussion/Decision Regarding Surplus Items to Auction; Resolution

Commissioner Bradshaw made a motion to approve Resolution #2022-24 approving the surplus and auction of the equipment, vehicles and miscellaneous items listed in Exhibit "A". Commissioner Connolly seconded the motion. All in favor. The motion passed.

- 3) Action Item: Discussion/Decision Regarding Bid Advertisement, 2022 Liquid Asphalt Commissioner Connolly made a motion to approve this Notice of Advertisement for the 2022 Liquid Asphalt Bid Proposals. Commissioner McDonald seconded the motion. All in favor. The motion passed.
- 4) Action Item: Discussion/Decision Regarding Bid Award, 2022 Asphalt Projects; \$1,213,116.50 Commissioner Bradshaw made a motion to award the Bonner County Asphalt Projects 2022 Base Bid to Coeur D'Alene Paving, Inc. for an amount of \$1,213,116.50 and allow The Board to sign the contract. Commissioner Connolly seconded the motion. All in favor. The motion passed.

#### AIRPORT - Dave Schuck

1) Action Item: Discussion/Decision Regarding Priest River Airport, Grant Application, Snow Removal Equipment

Commissioner Connolly moved that Bonner County submit this grant application for \$300,000 to ITD Division of Aeronautics. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw made a motion to enter into this maintenance agreement and that the Chairman sign administratively. Commissioner Connolly seconded the motion. All in favor. The motion passed.

#### **SOLID WASTE** – Brandon Staglund

1) Action Item: Discussion/Decision Regarding Midway Solid Waste Collection Site, Survey Contract for Boundary Line Adjustment; \$4,000.00

Commissioner Connolly made a motion to authorize the Chairman to sign the attached contract for surveying services from James A. Sewell & Associates, in the lump sum amount of \$4,000. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

### TREASURER - Cheryl Piehl

1) Action Item: Discussion/Decision Regarding Excess Tax Deed Funds, Idaho State Treasurer Unclaimed Property Department

Commissioner Bradshaw made a motion to approve Resolution #22-25 approving the payment of excess tax sale funds in the amount of \$16,025.20 to the Idaho State Treasurer Unclaimed Property Department. The time for recorded parties of interest and record owners to make a claim for the overage has passed for RP58N01W200152A. This has been reviewed and approved by legal. Commissioner Connolly seconded the motion. All in favor. The motion passed.

On Wednesday, March 23, 2022 a Planning Hearing was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly move to approve this petition, FILE #VS0012-21 requesting to vacate a 1,505 square feet portion of the 50 feet wide public right-of-way known as Garfield Bay Road located in Section 22, Township 56 North, Range 1 West, Boise Meridian, Bonner County, Idaho, and recorded in Book 80 of Deeds, Page 355, records of Bonner County, Idaho through Instrument #34688 on May 24, 1950, finding that it is in accord with Idaho Code §40 as enumerated in the foregoing conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report (or as amended during this hearing) and direct planning staff to draft written findings and conclusions to reflect this motion, have the chairman sign, record, and transmit to all interested parties. This action does not result in a taking of private property. The action that could be taken to obtain the vacation is to complete the Conditions of Approval as adopted. This action does not result in a taking of private property. Commissioner McDonald stepped down from the Chair and seconded the motion. Roll call vote: Commissioner McDonald – Aye, Commissioner Connolly – Aye, All in favor. The motion passed, RESOLUTION ADOPTION: Commissioner Connolly moved to approve resolution #2022-21 vacating a portion of Garfield Bay Road as shown on the submitted site plan. Commissioner McDonald stepped down from the Chair and seconded the motion. Roll call vote - Commissioner McDonald - aye, Commissioner Connolly - aye. All in favor. The motion passed. Commissioner Connolly made a motion to uphold the Planning and Zoning Commission's denial of this project FILE V0025-21, requesting to divide a 10-acre parcel into two (2) properties, approximately 5-acres in size, based upon the following conclusions: [REFER TO FOREGOING CONCLUSIONS OF LAW AND SPECIFY WHICH CONCLUSIONS THE PROJECT MEETS AND FAILS TO MEET]. The decision is based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report (or as amended during this hearing) and direct planning staff to draft written findings and conclusions to reflect this motion, have the Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property.
