Financing will be provided at the 3.99% fixed rate for two graders for a total of five years with an annual payment of \$59,354.99 this will provide for an interest rate lock of 3.99% through August 31st, 2022, the third grader will have a fixed rate of 4.55% locked through October 25th,2022, with an annual payment of \$31,297.28.
