On Tuesday, August 23, 2022, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. 4) Action Item: Discussion/Decision Regarding Guardrail Expenditure; \$63,686.88 Commissioner Bradshaw made a motion to approve this expenditure of \$63,686.88 to hire Frank Gurney, Inc. to install guardrail on Upper Pack River Rd and Gold Creek Road. Commissioner Connolly seconded the motion. All in favor. The motion passed.
