MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

August 30, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, August 30, 2022, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Mark Hammer and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Connolly made a motion to adopt the order of agenda as presented. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

PUBLIC COMMENT -

Kristina Kingsand – Spoke regarding her removal from the Zoning Commission

Commissioner Bradshaw made a motion to approve the Consent Agenda as presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

EMS - Jeff Lindsey

- 1) Action Item: Discussion/Decision Regarding Notice of Intent to Renew, Ambulance Lease Commissioner Connolly made a motion to approve and sign the Notice of Intent to Renew with Columbia state Bank for the ambulance lease. The adopted budget includes the expenditure of funds for Bonner County EMS lease for the 2022-2023 renewal term. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
- Action Item: Discussion/Decision Regarding Contract Renewal, MultiMedical Systems, LLC; \$1,907.50

Commissioner Bradshaw made a motion to approve and sign the contract for MultiMedical Systems, LLC provide periodic maintenance and repairs on the listed medical equipment that Bonner County EMS currently owns. This contract term is for 36 months at a cost of \$1,907.50 annually. Commissioner Connolly seconded the motion. All in favor. The motion passed.

On Wednesday, August 24, 2022 Tax Cancellations were held pursuant to Idaho Code §74-204 (2). The following files were Approved: MH56N05W206602A, RP58N02W262701A, RP57N03W105855A, MH58N02W262701A & RP007480000110A; Denied: RPS388700002A0A & RP58N04W355402A.

On Wednesday, August 24, 2022 a Planning Hearing was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly made a motion to deny this project FILE MOD0008-21, requesting a modification of a Conditional Use Permit C925-09, previously approved for a mooring operation in 2009, to now include one additional parking space, based upon the following conclusions of law found in the Staff Report: the site plan does not show sufficient space to accommodate additional parking spaces required for the expansion of the marina operation, structures on the property are not meeting the required setbacks, traffic circulation for the proposal is not meeting the code, the site plan is incomplete, the proposal is not meeting other state agency's requirements. The decision is based upon the evidence submitted up to the time the Staff Report was prepared, and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report (or as amended during the hearing) and direct planning staff to draft written findings and conclusions to reflect this motion, have Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property. The action that

could be taken, if any, to obtain the zone change is to: 1) File a new application with the Planning Department and meet the standards required by Bonner County Revised Code; or 2) Pursue such remedies as may be applicable at Title 67, Chapter 65, Idaho Code. Commissioner Bradshaw seconded the motion. Roll Call Vote: Commissioner McDonald – Aye. Commissioner Connolly – Aye. Commissioner Bradshaw – Aye. The motion passed. Commissioner Bradshaw made a motion to approve this project, FILE CUP0030-21, requesting a conditional use permit for an RV Park, finding that it is in accord with the general and specific objectives of the Bonner County Comprehensive Plan and Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Report and direct planning staff to draft written findings and conclusions to reflect this motion, have Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property. Commissioner Connolly seconded the motion. Roll Call Vote: Commissioner McDonald – Aye. Commissioner Connolly – Aye. Commissioner Bradshaw – Aye. The motion passed.

On Monday, August 29, 2022 A Special Meeting regarding SRS Funding & Opioid Settlement was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly made a motion to reallocate the Title 3 SRS funds at 15% and title 1 at 85% and zero to title 2. Commissioner Bradshaw stepped down from the Chair and seconded the motion. All in favor. The motion passed. Commissioner Connolly made a motion to divert any monies received from the Opioid settlement be diverted to Panhandle Health District. Commissioner Bradshaw stepped down from the Chair and seconded the motion. All in favor. The motion passed.

On Monday, August 29, 2022 a Planning Appeal was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly made a motion to affirm the staff's decision to deny this project FILE VA0016-22, requesting to create two approximately 9.2 acre lots where 10 acres is required in A/F-10 zoning on an 18.40 acre unplatted parcel located in Section 24, Township 58 North, Range 01 West, Boise Meridian, Bonner County Idaho, finding that it is in accord with the Bonner County Revised Code as enumerated in the following conclusions of law, and based upon the evidence submitted up to the time the Staff Report was prepared and testimony received at this hearing. I further move to adopt the findings of fact and conclusions of law as set forth in the Staff Memo and direct planning staff to draft written findings and conclusions to reflect this motion and transmit to all interested parties. This action does not result in a taking of private property. Commissioner seconded the motion. Roll Call Vote: Commissioner McDonald - Aye. Commissioner Connolly - Aye. Commissioner Bradshaw - Aye. The motion passed. Commissioner Bradshaw moved to uphold the previous determination for administrative approval on the preliminary plat for this project FILE MLD0059-22, Wood View Acres, a request to divide a ≈6.27-acre parcel into four (4) lots, one (1) 1.06-acre lot, two (2) 1-acre lots, and one (1) 3.49-acre lots, finding that the minor land division as proposed IS in accord with the Bonner County Revised Code. Commissioner Bradshaw further moved to adopt the findings of fact and conclusions of law as set forth in the Staff Memo and direct planning staff to draft written findings and conclusions to reflect this decision, have the Chairman sign, and transmit to all interested parties. This action does not result in a taking of private property. Commissioner Connolly seconded the motion. Roll Call Vote: Commissioner McDonald - Aye. Commissioner Connolly - Aye. Commissioner Bradshaw - Aye. The motion passed.
