# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

October 25, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, October 25, 2022, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Dan York and the Pledge of Allegiance followed.

#### ADOPT ORDER OF THE AGENDA

Commissioner Bradshaw made a motion to adopt the order of agenda presented. Commissioner Connolly seconded the motion. All in favor. The motion passed.

1) Action Item: Discussion/Decision Regarding Inmate Housing Agreement, Kootenai Tribe of Idaho Commissioner Connolly made a motion to approve the Adult Detention Agreement between the Kootenai Tribe of Idaho and Bonner County to house male and female inmates at the Bonner County detention facility. The Tribe will reimburse Bonner County \$90 per day per inmate with the agreement being effective from date of execution until November 30, 2023. This contract is identical to the previous contract, except dates. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.
