# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

November 8, 2022 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, November 8, 2022, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners McDonald, Connolly & Bradshaw present. Commissioner McDonald called the meeting to order at 9:00 a.m. The Invocation was presented by Chris Bassett and the Pledge of Allegiance followed.

Commissioner Connolly made a motion to approve entering into a Memorandum of Agreement with the Idaho Department of Lands to maintain the 2.5 mile portion of Eastshore Road from Canoe Point ending where Sandpiper Shores intersects Eastshore Road once all requirements have been met to the satisfaction of the Road and Bridge Department and to sign accordingly. Commissioner Bradshaw seconded the motion. All in favor. The motion passed.

#### EMS - Jeff Lindsey

- 3) Action Item: Discussion/Decision Regarding Declaration of a Local Disaster Emergency; **Resolution ADD** Commissioner Connolly made a motion to approve Resolution #2022-93 and declare that a local disaster emergency exists in Bonner County, Idaho due to heavy rain and saturated soils causing a landslide on Rocky Point Road. Commissioner Bradshaw seconded the motion. Roll Call Vote: Commissioner McDonald Aye. Commissioner Connolly Aye. Commissioner Bradshaw Aye. The motion passed.
