On Wednesday, December 7, 2022 Assistance was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly made a motion to remand the bid over to the Airport Director for review and recommendation. Commissioner McDonald stepped down from the Chair and seconded the motion. All in favor. The motion passed.

On Tuesday, December 6, 2022 a Bid Opening for the Airport was held pursuant to Idaho Code §74-204 (2).

On Wednesday, December 7, 2022 a Panhandle Health District Representative Workshop was held pursuant to Idaho Code §74-204 (2).

On Wednesday, December 7, 2022 a Planning Hearing was held pursuant to Idaho Code §74-204 (2). Commissioner Connolly made a motion to approve the recommended updates to the Property Rights and the Recreation components of the Comprehensive Plan, File AM0015-22, as amended in this hearing, finding that it is in accord with the requirements of Idaho Code §67-6508 and the procedures of Idaho Code §67-6509. This action does not result in a taking of private property. Adding the City of Priest River comments and the Idaho Fish and Game comments as discussed. Commissioner McDonald stepped down from the Chair and seconded the motion. Roll Call Vote: Commissioner McDonald – Aye. Commissioner Connolly – Aye. The motion passed. Commissioner Connolly made a motion to approve Resolution # 2022-103, adopting the recommended updates to the Property Rights and the Recreation components of the Comprehensive Plan and repealing the previously adopted Property Rights and Recreation components in the Comprehensive Plan. Commissioner McDonald stepped down from the Chair and seconded the motion. Roll Call Vote: Commissioner McDonald – Aye. Commissioner Connolly – Aye. The motion passed.
