MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

January 17, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, January 17, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt and Williams present.
