MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

January 24, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, January 24, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt and Williams present. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Janine Shepard and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Williams made a motion to adopt the order of agenda as presented. Commissioner Omodt seconded the motion. All in favor. The motion passed.

DISTRICT 2 REPORT – Commissioner Williams gave a brief report of the meetings she has attended and what she has been doing for the week previous to today's meeting. Gave an update on community concerns on open meeting law, and other community concerns. Requested to agendize/discuss putting the P&Z Commission back together as one.

Commissioner Williams requested that the District 3 update should have been agendized.

DISTRICT 3 REPORT – Commissioner Omodt commented on our current open meeting practice, stated that he has been learning about how open meeting law works and that he has been in discussion with our Prosecutor's Office. Discussed his request to host a monthly meeting with all elected officials, gave an update on where that meeting planning is, meetings will be open to the public, but will accept no public comment.
