MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

February 7, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, February 7, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt and Williams present. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Ken Lawrence and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Omodt made a motion remove BOCC Item #2 Action Item: Discussion/Decision Regarding Reimbursement (FY22) to Assessor Grant Dorman. Commissioner Williams seconded the motion. All in favor. The motion passed.

Commissioner Omodt made a motion to adopt the order of agenda as amended. Commissioner Williams seconded the motion. Commissioner Williams asked for clarification on whether or not the "zoom meeting discussion" should be under Executive Session. Attorney, Bill Wilson spoke regarding the options. Roll Call Vote: Commissioner Omodt: Yes; Commissioner Williams: No. Commissioner Bradshaw: Yes. The motion passed.

DISTRICT 2 REPORT – Commissioner Williams spoke about behavioral health support that is available in the county. She encouraged anyone that wishes for the continuance of Zoom to speak up, she read multiple written comments into the record.

DISTRICT 3 REPORT – Commissioner Omodt spoke about a site visit at the Lillybrooke Center that he attended. He also addressed the current lawsuits that Bonner County faces. Discussed the IAC Conference that the BOCC attended last week.

PUBLIC COMMENT

- -John Elsbury, Latah County Surveyor, spoke regarding the proposed boundary line adjustment that will come in front of the BOCC at a later date, once it has been legally vetted.
- -Randy Stolz, questioned the Planning Commission vacancies.
- -Grant Dorman, endorsed the boundary line adjustment spoken of in the beginning.
- -Dave Bowman, expressed his support of combining the Planning and Zoning Commissions into one and spoke about RV parks and the density they create. Requests the zoom option for meetings to continue.
- -Doug Paterson, feels that "silencing a commissioner" was grossly-unfair and thought the boundary line adjustment public comments should have been agendized in cause a member of the public wanted to provide input. Agrees with Dave Bowman's comments.
- -Jonna Plante, agrees with Dave Bowman relating to the RV park, also agrees with Commissioner Williams relating to not having a zoom meeting discussion under executive session.

- -Clerk Michael Rosedale, agrees the zoom option should initially be discussed under Executive Session and then discussed at a public meeting later.
- -Trisha Bowlin, agrees with the zoom and RV comments.
- -Marsha Stephens, is out of state and requests the zoom option to continue.
- -Shari Dovale, supports Dave Bowman's comments related to the combination of Planning and Zoning commissioners and the RV park, agrees that the zoom meetings should continue. Feels that the point of order is disrespectful.
- -Jeremy Grimm, supports the continuance of zoom meetings. Agrees with the Dave Bowman comment about RV parks.
- -Deanne Fultz, agrees with Dave Bowman's RV comments and the continuance of zoom meetings.
- -Theresa Hiesener, talked about the RV park, supports the zoom meeting option, requests planning and zoning commissions to combine as one, and agrees with the disrespect toward Commissioner Williams.
- -Mary Rawlsky, agrees with RV and zoom comments.
- -Susan Bowman, agrees with the RV Park amendment, having more "sunlight" as to who gets appointed on the planning and zoning commissions, supports Commissioner Williams' item #3, the reimbursement for the appeal and supports the combination of commissions. Agrees with the continuance of zoom meetings.
- -Reg Crawford, considers zoom very valuable and feels that it should not be discussed under executive session. Would like to see the RV park code amended and disagrees with the point of order.
- -Kristina Anderson, spoke asking about the relationship with the Fair Board and whether or not it is appropriate to bring up at this time. Referenced how the Fair board should operate according to Idaho Code. According to the website, there are expired members and therefore questions how they are able to conduct regular business and enter into executive sessions. Supports the continuance of zoom meetings.

- -Jeanette Benedelli, agrees with the wish for the RV park code to be amended.
- -Mike Wilson, requests the respect for all commissioners.
