MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

February 21, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, February 21, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt and Williams present. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Clerk Michael Rosedale and the Pledge of Allegiance followed.

ADOPT ORDER OF THE AGENDA

Commissioner Williams made a motion to adopt the order of the agenda as presented. Commissioner Omodt seconded the motion. All in favor. The motion passed.

Commissioner Bradshaw mentioned that there was a loss of a ring and thanks to the person who found it, and clarification for the Planning Hearings that will still have zoom if it was already advertised as such.

DISTRICT 2 REPORT – Commissioner Williams spoke about the numerous emails that she received from constituents wanting zoom to continue. Also concerns regarding human resources being put under executive session.

DISTRICT 3 REPORT – Nothing to report.

PUBLIC COMMENT – Commissioner Bradshaw stated that public comment would be limited to 12 minutes total.

Dave Bowman, spoke regarding the hiring of Davillier Law Group for training for other elected officials, read an opinion from the Attorney General's office (provided statement for the record).

- -George Gehrig, spoke regarding being 1000% in favor of recalling for bullying and the request to continue with zoom. Also spoke about the inaudibility of a lot of the recorded meetings. Spoke about the Natural Resources Committee and the need for them to weigh in on the comprehensive plan.
- -Ron Korn, spoke regarding the ability to speak during the public comment period without being threatened by having the cops called in case they say something one or more of the commissioners don't like.
- -Commissioner Bradshaw clarified that this meeting is not just a public comment meeting but a meeting for business and public comment is a privilege and needs to not be derogatory in nature.
- -Jennifer Cramer, spoke regarding zoom and how she wishes that to continue, feels the threat of a potential lawsuit is an excuse.
- -Rick Cramer, spoke regarding the front-page article in the paper and how it was embarrassing. States that the commissioners don't have to right to regulate speech.
- -Trisha Bowlin, asked if it was ethical for an elected official to receive money in donations from a law firm that they now hire as the board of commissioners. She said according to state statute that it could be considered bribery/corruption.
- -Commissioner Williams said that this is a matter of transparency and there could be a valid concern.

- -Shari Dovale, spoke regarding the need for zoom for the disabled and the handicap. Said that just because it is "legal" to remove zoom it doesn't mean it is the "right thing to do".
- -Randy Stolz, spoke regarding the appreciation and support for Commissioner Bradshaw comments regarding the need for an orderly business meeting and the need for transparency. Feels limiting public comment and removing zoom is a step backward and is an invitation for lawsuit.
- -Jim Kelly, spoke regarding the request for zoom to be reinstated. Read a quote from Scott Herndon. Attended all candidate forums and reminded them of the repeated slogan "we will work for you" the constituents of Bonner County. Said there is an overwhelming amount of people that support zoom and not one comment against having the zoom capability.

- 4) Action Item: Discussion/Decision Regarding Request for Increase in Petty Cash Funds, Solid Waste Commissioner Williams made a motion to authorize the County Treasurer to transfer \$100.00 from the Treasurer's Account to the Solid Waste Westside Assistant Manager's petty cash drawer to assist with supplying change to other Solid Waste sites. Commissioner Omodt seconded the motion, All in favor. The motion passed.
