# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

May 2, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, May 2, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt and Williams present. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Bruce Macek and the Pledge of Allegiance followed.

# PUBLIC COMMENT – Allowance of 60 minutes.

- David Mann, spoke regarding a zone change that was discussed in a Planning Hearing during the prior week. Also spoke regarding wetland setbacks. Commissioner Williams said to speak with Planning in regard to the 40' setback requirement.
- Monica Gunter, spoke regarding where the Fairboard may want the placement of the campground and whether or not Commissioner Omodt has scheduled a promised meeting with the Fairboard members.
- Jessica Frye, said she attended the Fairboard workshop and that it was a nice meeting.
- Brian Domke, requested that the county commissioners request the planning commission to reengage with subarea committees for comp plan amendments.
- Wayne Martin, requested five minutes for public comment.
- Dan Rose, whether there would be another agenda item related to the Solid Waste Capital Improvements Project. Asked for clarification of the selection of nominees for the Natural Resources Committee and Fairboard.
- George Gehrig, spoke regarding an email received about the non-selection of himself for the Natural Resources Committee and questioned the selection process. Provided documents related to the Forest Service which he has concerns about.
- Shari Dovale, would like associated documents attached to the agenda for the public to view, also requested other special meetings to either be on Zoom and/or YouTube.
- Spencer Hutchings, asked if Commissioners Omodt and Bradshaw are under physical duress or financial pressure as to why there is a flip-flop to the fairground campground expansion.
- Doty Glass, stated Commissioner Omodt should stop saying "I, I, I" and it should be "Us, Us, Us."
- Dan Rose, spoke about the republican party platform.
- Fred Arn, asked if there were any studies done that would make sure that the campground expansion would be a viable business that would turn a profit. Commissioner Omodt addressed market rate.
- Theresa Hiesener, reiterated Brian Domke's comment on the subarea committee suggestion. Thanked Commissioner Williams for hosting the Spirit Valley Town Hall. Feels that the Sheriff's Office needs a budgetary increase due to some traffic issues that need to be addressed.
- Monica Gunter, said that the proposed campground expansion is not saving taxpayer money due to the chances of having to tear down at a later date.
- Doug Paterson, spoke about private versus public campgrounds.
- Dimitry Borisov, asked about the Sandpoint Mayor's accusations of citizens being members of the "Taliban." Thinks the board should write a letter to the mayor.

- Wayne Martin, asked about where the money from campground rental goes and what other locations would be possible for the expansion. Commissioner Omodt stated that there has been extensive research on the choice for the location of the expansion that started with the previous board of commissioners.
- George Gehrig, affirmed the comments about the Sandpoint Mayor. Also spoke about the potential conflict of interest of campaign donations from volunteer selection of committees/boards.
- Jennifer Arn, said she has no dog in the fight about the fairgrounds issue, asked about the cost to maintain and volunteered to mow the area to help lower costs.
- Kristina Nicholas Anderson, said she wants the best for the fair and the idea of putting the campground where the house is would not be fiscally responsible due to the large amount of income that is received from rent.
- Spencer Hutchings, asked about the amount of the grant.

Commissioner Bradshaw recessed the meeting for five minutes at 9:59 a.m. Commissioner Bradshaw reconvened the meeting at 10:05 a.m.

Commissioner Williams spoke about the extensive legal review that the policies have gone under and the need to update the antiquated versions. Commissioner Omodt read Robert's Rules into the record in regard to seconding a motion. Commissioner Williams asked Commissioner Omodt to address what his exact concerns are. Commissioner Bradshaw stated that there was not a second so therefore the motion has died.

Action Item: Discussion/Decision Regarding Fairboard RV Campground Grant Application Commissioner Williams stressed that the Fairboard needs to weigh in before the campground grant moves forward. Civil Attorney Scott Bauer addressed the MOU that was signed during the special meeting that was scheduled on 4/27/2023. Sheriff Wheeler spoke to the drawings done by Sewell & Associates. Asked whether any of the elected officials were consulted for future growth. Spoke to the history of development in this area. Commissioner Williams asked Monica Gunter to speak. Monica Gunter said she spoke to Idaho Parks and Recreation in Boise and explained what would happen if the campground expansion would have to be torn down. Scott Bauer added that statutorily, the Fairboard needs to be a part of this process. Commissioner Bradshaw requested a motion. Shari Dovale asked what Phase we are at on this project. Commissioner Omodt explained what was involved in the first phase. Karlene Behringer asked about a proposed justice center and if there would be any court space included. Commissioner Williams talked about the growth need related to a justice center. Brian Domke said as a land planner, the conceptual plan has no merit and that there are very pertinent issues. Commissioner Williams said she was going to do two separate motions. Doty Glass said to listen to "we the people." Commissioner Williams made a motion that the April 27th, 2023 memorandum to engage Sewell & Associates for \$25,000.00 for a property line adjustment be vacated based on the fact that there was no unforeseen circumstances and that we prior that the memorandum of understanding is not a valid document. Commissioner Omodt said this was reviewed by legal and signed by both the Fairboard and Board of County Commissioners. He said that the scope of work was also drafted by legal. Commissioner Williams said that it was reviewed by legal, however there was additional information after that was created, therefore making it not correct. No second. The motion died. Commissioner Williams made a motion with respect to the stated memorandum of understanding dated April 27th, 2023, where in the Bonner County Commissioners identified the piece of land located at 10-57N-2W be used exclusively for the Bonner County Fair exclusively as a campground be vacated based on the information presented in this meeting and in prior meetings and to reiterate that their memorandum does not allow for us to park, we have a fair coming up and it says exclusively for a campground. Commissioner Omodt said he would not second due to similar reasons that have already been stated. No second. The motion died.

The meeting was recessed at 11:23 a.m. The meeting was reconvened at 11:31 a.m.
