# MINUTES FOR THE BONNER COUNTY BOARD OF COMMISSIONERS' MEETING

September 19, 2023 – 9:00 A.M. Bonner County Administration Building 1500 Hwy 2, Suite 338, Sandpoint, ID

On Tuesday, September 19, 2023, the Bonner County Commissioners met for their regularly scheduled meeting with Commissioners Bradshaw, Omodt, and Williams present. Commissioner Bradshaw called the meeting to order at 9:00 a.m. The Invocation was presented by Pastor Scott Acklin and the Pledge of Allegiance followed.

#### **PUBLIC COMMENT**

- Patty Omodt Transparency in Idaho Public Record Act. Discuss use of personal devices during public business meeting, noted that this is part of public record, violation of Idaho Public Records Act.
- Dian Welle Regarding when Mr. Hutchings be removed during the meeting two weeks prior, read transcript from this meeting.
- Darla Fletcher Transparency and the necessity of this in government for public trust. Brought up cell phone use during public meeting and the public record request for these records that do not exist, this cell phone replaced with laptop. Want true transparency and wants to be able to trust all. If using personal devices, please share what is going on during the meetings.
- Diane Madoski Issues during Zoom and YouTube not allowed to be part of recesses while online. Request that during recesses the public online not be muted and can see what is going on.
- Dimitri Borisov Agenda items need to be posted in 48 hours, public comment limited to three minutes which does not allow time to summarize/rebut and only get partial answers
- Trisha Bowlin Inquired about the packet being posted online. Brought up taking pictures with cell phone.
- Wayne Martin Consider 5 minutes or up to 5 minutes for public comment. Noticed that a laptop has been present often. Transparency from all, not just regarding cell phone use during meetings.
- Susan Bowman Attacks on freedom of speech by not allowing public comment during meetings and by calling too many recesses.
- Spencer Hutchings Transparency thing suddenly so important, short notice meetings are not transparent, short notice/emergency meetings are bad for the public.
