Commissioner Omodt called the meeting to order at 9:01 a.m. The Invocation was presented by Pastor Mark Hammer and the Pledge of Allegiance followed.

\$406,465.47 from FY24 00118/9480 and \$174,199.48 from FY24 99918/9480 to FY23 00118/9480 and 99918/9480 to correct the Capitol Construction Budget amount. Commissioner Omodt stepped down from the chair and seconded the motion.

1) Action Item: Discussion/Decision Regarding Grant Reimbursement Request USFS, Gold Hill Parking Project, Requesting \$25, 501.20

Commissioner Bradshaw made a motion that the County sign the request for partial reimbursement of grant #21-DG-11010400-018 in the amount of \$25,501.20. Commissioner Omodt stepped down from the chair and seconded the motion. Roll call vote: Commissioner Williams – Absent, Commissioner Omodt – Yes, Commissioner Bradshaw – Yes. The motion carries.

2) Action Item: Discussion/Decision Regarding Grant Closeout Request USFS, Gold Hill Parking Project Commissioner Bradshaw made a motion that the County sign the request for final closeout of grant #21-DG-11010400-018. Commissioner Omodt stepped down from the chair and seconded the motion. PUBLIC COMMENT

Doug Paterson – How many parking spaces are in this lot?

Kevin Moore - How much did the County actually spend on this?

Rick Cramer – Wanted to clarify on how many parking spaces there are?

Roll call vote: Commissioner Williams – Absent, Commissioner Omodt – Yes, Commissioner Bradshaw – Yes. The motion carries.

BOCC – Commissioner Luke Omodt

1) Action Item: Discussion/Decision Regarding ICCO/Hayden Ross Letter

Commissioner Omodt stepped down from the chair and made a motion for the BOCC to approve the draft letter to Hayden Ross, LLC reflecting: 1. The FY 2022 and previous years Audited Financial Statements did not include operations of the Bonner County Fairgrounds 2. Bonner County is not pursuing a reissuance of previous years audited financial statements to include operations of the Bonner County Fairgrounds 3. The FY 2023 Audited Financial Statement will include operations of the Bonner County Fairgrounds as a component unit of Bonner County 4. The Bonner County and operations of the Bonner County Fairgrounds audited financial statements will be conducted by different independent auditors. And allow for the chairman to sign for the BOCC. Commissioner Bradshaw seconded the motion.

PUBLIC COMMENT

Doug Paterson – Was the letter on the notice?

Dave Bowman - Auditors independent from who?

Susan Bowman – Where is the money coming from for the audit? What is the state statute that the BOCC is in charge of audits?

Rick Cramer - Thinks that you should recognize loss of trust.

Doug Paterson - The state AG used to come around and give lectures on state open meeting laws.

Dimitri Borisov – There has been a lot of talk about the BOCC being responsible for the audit, but then Commissioner Bradshaw stated they have no right to tell any board what to do, yet all of the boards in the county are elected except the Fairboard as the Fairboard is appointed by the commissioners, how would you reconcile that? Jennifer Cramer – Disagrees with not looking to prior years to understand what went wrong. Hearing contradictory statements

Kristina Nicholas Anderson – Does not think the County can not afford to not go back to audit prior to 2023, there are bank statements and a Google drive and boxes of records. Thinks it is good stewardship to get a quote from Ide Bailey for an audit.

Roll call vote: Commissioner Williams – Absent, Commissioner Omodt – Yes, Commissioner Bradshaw – Yes. The motion carries.

PUBLIC COMMENT *

Amy Lunsford – I've been coming to the meetings for months asking about the investigation of the Fairboard embezzlement. And now we are told there are no records. Glad that everyone is moving forward in a positive way. Discussed ICCO and the elected official who may have been involved shed light on this corruption.

Jennifer Cramer – The RFP meeting for the audits this week requests that Commissioner Williams be present. Had a question for Commissioner Omodt regarding the discussion that the board should follow the same procedure as the staff as submitting agenda items, there was no vote, if that is the process, you did not do it with the Hayden Ross thing.

Rick Cramer – Request that the Roberts Rules of order be on the agenda. Question about posting PRR online if there had been legal review yet.

Kristina Nicholas Anderson – There has been an increased interest in the Fairboard meetings. Request that this board assist in helping the Fairboard with Zoom during meetings.

Susan Bowman – Last week an apology was offered to Ms. Plante regarding the Pledge of Allegiance. Discussed taking "under God" out of the Pledge. We are watching tyranny in action and taking away freedom of speech. Dan Welle – Those who forget the past are condemned to repeat it. An online comment about going up against corruption and lawlessness in the County. Failing to look into the past will hinder going forward. Need to go back in an audit to help the community heal.

Dian Welle – Shield of faith covers our heart. We need the protection that the shield provides now more than ever. This board and the public have allowed hate and deceit to take over Bonner County. Commissioner Bradshaw should be an example of understanding and kindness and you are showing the opposite. Commissioner Omodt your rude behavior and condescending attitude is appalling, be the leader that the military trained soldiers to be. Dimitri Borisov – When Roberts Rules was adopted, should not pick and choose which rules to follow. Idaho rules do give a lot of leeway, please do more than the bare minimum.

Dave Bowman – Regarding ICCO, consists of elected officials in charge of their own departments and they are not subject to open meeting laws. Two weeks ago commented on the October 16 meeting, that there was no plan. Darla Fletcher – Request an item for the agenda: the facilities and who should be in charge of winterizing and buildings and that it be placed under maintenance.

Kevin Moore – Pros and cons to public comments being at the end. Please consider putting public comment at the beginning and the end of the meeting and allowing more public comment.

Commissioner Omodt called a 5-minute recess at 11:04 a.m. Reconvened at 11:12 a.m.

Kristine Noella – Wanted to reiterate that the HR department be back under the Prosecutor office.

Shari Dovale – Concerns about the Fair audit and the clerk having never been asked. The county is the victim in this and should have filed a complaint so that it could have been investigated. Discussed other examples of groups that could be subject to open meeting law.

Spencer Hutchings – The lack of transparency has affected the Fair. We all want to know what the financial dealings of the fair are, what happened to the money and let the public know. The commissioners should file a complaint so that it is investigated.

Dana Sanchez – Unsure how the Fairboard could not keep bookkeeping records for ten years. The hostile working environment caused her to lose her sister, Darcey Smith, wants justice for her sister.

DISTRICT 1 COMMISSIONER REPORT – Commissioner Bradshaw had nothing to report at this time.

DISTRICT 3 COMMISSIONER REPORT – Commissioner Omodt gave an extensive report of issues and activities.

Commissioner Omodt called a 5-minute recess at 11:37 a.m. Reconvened at 11:43 a.m.
