

# AGREEMENT FOR SHERIFF'S BOAT MOORAGE BETWEEN THE CITY OF SANDPOINT AND BONNER COUNTY

In consideration of the mutual covenants and promises set forth in this Agreement, the City of Sandpoint (hereafter referred to as "City of Sandpoint"), a municipal corporation of the State of Idaho, and Bonner County, (hereafter referred to as "Bonner County"), a municipal corporation of the State of Idaho, do hereby agree as follows:

### 1. Purpose.

The purpose of this Agreement is to provide regular, seasonal Windbag Marina boat moorage for one (1) Bonner County Sheriff boat, as needed temporary moorage for 1-2 additional Sheriff boats, and as needed and approved in writing by the Mayor or designated/authorized City representative, moorage for Sheriff boats in the event of an emergency situation/response. Moorage to be effective on or after May 15, 2024 dependent on acceptable lake levels at BCMS Slip and shall continue through October 15, 2024, dependent on lake levels at BCMS Slip.

#### 2. Location

Bonner County shall utilize BCMS Slip, as identified on Windbag Marina map attached hereto for reference.

### 3. Termination

This Agreement shall terminate October 15, 2024, unless terminated earlier by either party for any reason with 30 days' written notice. The parties may renew this Agreement for an additional one-year term, commencing May 15, 2025, upon terms and conditions mutually acceptable to them, by giving written notice on or before April 01, 2025.

### 4. Insurance

At all times material hereto, Bonner County shall keep and maintain a policy or policies of insurance covering losses resulting from general liability, personal injury and property loss, in amounts no less than the limits of liability provided Idaho Code §6-901 through 6-929, known as the Idaho Tort Claims Act, for any losses sustained as a result of performance of each parties duties and responsibilities under this Agreement, naming the City of Sandpoint as Certificate Holder on each such policy or policies. Bonner County shall also keep and maintain an automobile and watercraft insurance policy or policies for each of its employees, in the same amounts stated above, insuring against losses related to operation of its vehicles or vessels in performance of its duties under this Agreement.

### 5. Indemnification.

a. Bonner County shall indemnify and hold the City of Sandpoint, its officials, officers, employees, agents and assigns, harmless from and/or against any and all claims, damages, and liabilities (including reasonable attorney's fees) that may be suffered or incurred or that arise as a result of and which are caused by Bonner County's wrongful acts or omissions in the performance of its duties under this Agreement. This indemnification does not apply when such claims, damages, and liabilities are the result

of negligent acts, errors, omissions or fault on the part of the City of Sandpoint, its officials, officers, employees, agents or assigns. Nothing contained in this indemnification provision shall waive, in any manner, the limits of liability provided to the City of Sandpoint specified in Idaho Code §6-901 through 6-929, known as the Idaho Tort Claims Act.

### 6. General Provisions.



On April 25, 2023, Bonner County Board of Commissioners awarded the 2023 Colburn Improvements Project in the amount of \$6,285,393.00.

Solid Waste is requesting that the Board of Commissioners execute the attached loan resolution provided by the USDA in the amount of \$8,137,000.00. The USDA requires this document be ratified by the Board in order to close the loan in the new amount.

# LOAN RESOLUTION (Public Bodies)

A RESOLUTION OF THE County Commissioners
OF THE Bonner County
AUTHORIZING AND PROVIDING FOR THE INCURRENCE OF INDEBTEDNESS FOR THE PURPOSE OF PROVIDING PORTION OF THE COST OF ACQUIRING, CONSTRUCTING, ENLARGING, IMPROVING, AND/OR EXTENDING ITS
Public Body
FACILITY TO SERVE AN AREA LAWFULLY WITHIN ITS JURISDICTION TO SERVE.
WHEREAS, it is necessary for the Bonner County
(Public Body)  (herein after called Association) to raise a portion of the cost of such undertaking by issuance of its bonds in the principal amount of
Eight Million One Hundred Thirty Seven thousand & 00 100
pursuant to the provisions of Idaho Code Title 31 ; and
WHEREAS, the Association intends to obtain assistance from the United States Department of Agriculture, (herein called the Government) acting under the provisions of the Consolidated Farm and Rural Development Act (7 U.S.C. 1921 et seq.) in the planning. financing, and supervision of such undertaking and the purchasing of bonds lawfully issued, in the event that no other acceptable purchaser for such bonds is found by the Association:

- NOW THEREFORE, in consideration of the premises the Association hereby resolves:
  - To have prepared on its behalf and to adopt an ordinance or resolution for the issuance of its bonds containing such items and in such forms as are required by State statutes and as are agreeable and acceptable to the Government.
  - To refinance the unpaid balance, in whole or in part, of its bonds upon the request of the Government if at any time
    it shall appear to the Government that the Association is able to refinance its bonds by obtaining a loan for such purposes
    from responsible cooperative or private sources at reasonable rates and terms for loans for similar purposes and periods
    of time as required by section 333(c) of said Consolidated Farm and Rural Development Act (7 U.S.C. 1983(c)).
  - 3. To provide for, execute, and comply with Form RD 400-4, "Assurance Agreement," and Form RD 400-1, "Equal Opportunity Agreement," including an "Equal Opportunity Clause," which clause is to be incorporated in, or attached as a rider to, each construction contract and subcontract involving in excess of \$10,000.
  - 4. To indemnify the Government for any payments made or losses suffered by the Government on behalf of the Association. Such indemnification shall be payable from the same source of funds pledged to pay the bonds or any other legal ly permissible source.
  - 5. That upon default in the payments of any principal and accrued interest on the bonds or in the performance of any covenant or agreement contained herein or in the instruments incident to making or insuring the loan, the Government at its option may (a) declare the entire principal amount then outstanding and accrued interest immediately due and payable, (b) for the account of the Association (payable from the source of funds pledged to pay the bonds or any other legally permissible source), incur and pay reasonable expenses for repair, maintenance, and operation of the facility and such other reasonable expenses as may be necessary to cure the cause of default, and/or (c) take possession of the facility, repair, maintain, and operate or rent it. Default under the provisions of this resolution or any instrument incident to the making or insuring of the loan may be construed by the Government to constitute default under any other instrument held by the Government and executed or assumed by the Association, and default under any such instrument may be construed by the Government to constitute default hereunder.
  - 6. Not to sell, transfer, lease, or otherwise encumber the facility or any portion thereof, or interest therein, or permit others to do so, without the prior written consent of the Government.
  - 7. Not to defease the bonds, or to borrow money, enter into any contractor agreement, or otherwise incur any liabilities for any purpose in connection with the facility (exclusive of normal maintenance) without the prior written consent of the Government if such undertaking would involve the source of funds pledged to pay the bonds.
  - 8. To place the proceeds of the bonds on deposit in an account and in a manner approved by the Government. Funds may be deposited in institutions insured by the State or Federal Government or invested in readily marketable securities backed by the full faith and credit of the United States. Any income from these accounts will be considered as revenues of the system.
  - To comply with all applicable State and Federal laws and regulations and to continually operate and maintain the facility in good condition.
  - 10. To provide for the receipt of adequate revenues to meet the requirements of debt service, operation and maintenance, and the establishment of adequate reserves. Revenue accumulated over and above that needed to pay operating and maintenance, debt service and reserves may only be retained or used to make prepayments on the loan. Revenue cannot be used to pay any expenses which are not directly incurred for the facility financed by USDA. No free service or use of the facility will be permitted.

According to the Paperwork Reduction Act of 1995, an agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless it displays a valid OMB control number. The valid OMB control number for this information collection is 0572-0121. The time required to complete this information collection is estimated to average 1 hour per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information.

- 11. To acquire and maintain such insurance and fidelity bond coverage as may be required by the Government.
- 12. To establish and maintain such books and records relating to the operation of the facility and its financial affairs and to provide for required audit thereof as required by the Government, to provide the Government a copy of each such audit without its request, and to forward to the Government such additional information and reports as it may from time to
- 13. To provide the Government at all reasonable times access to all books and records relating to the facility and access to the property of the system so that the Government may ascertain that the Association is complying with the provisions hereof and of the instruments incident to the making or insuring of the loan.
- 14. That if the Government requires that a reserve account be established, disbursements from that account(s) may be used when necessary for payments due on the bond if sufficient funds are not otherwise available and prior approval of the Government is obtained. Also, with the prior written approval of the Government, funds may be withdrawn and

### **PROCLAMATION**

# IN SUPPORT OF BONNER COUNTY'S MILITARY CAREGIVERS IN COLLABORATION WITH IDAHO'S DAR AND HIDDEN HEROES

WHEREAS, the series of wars and conflicts in which our great nation has been engaged over time, since World War II, has resulted in 5.5 million military and veteran caregivers who are parents, spouses, siblings and friends, caring for those wounded, ill or injured who have served our nation, as documented by the 2014 RAND study commissioned by the Elizabeth Dole Foundation; and

WHEREAS, the daily tasks of these military and veteran caregivers can include bathing, feeding, dressing and caring for the injuries of wounded warriors, administering medications, providing emotional support, caring for the family and the home, and working outside the home to earn essential income; and

WHEREAS, the nation provides multi-faceted support to our wounded, ill and injured veterans and service members through public, private and philanthropic resources, but their caregivers receive little support or acknowledgement; and

WHEREAS, most military and veteran caregivers consider the challenging work they do as simply carrying out their civic and patriotic duty, without realizing they are, in fact, caregivers, and do not identify themselves as such; and

WHEREAS, an alarming number of military and veteran caregivers, according to research, are suffering numerous debilitating mental, physical and emotional effects as a result of their caregiving duties; and

WHEREAS, Bonner County desires to recognize and support those who are serving in these vital roles in our own community;

### NOW, THEREFORE, BE IT RESOLVED by the Bonner County Commissioners

- 1. That Bonner County become a Hidden Heroes County in support of military and veteran caregivers.
- 2. That Bonner County seeks to identify military and veteran caregivers residing in our communities and determine the unique challenges they face.

- 3. That Bonner County will work to ensure that our government, organizations, employers and non-profits are aware of the unique challenges of military and veteran caregivers and are encouraged to create supportive environments and opportunities for assistance.
- 4. That Bonner County will plan an annual observance, ideally in May for Military Appreciation Month and Month of the Military Caregiver, to honor and recognize the community's military and veteran caregivers in partnership with the Elizabeth Dole Foundation's national Hidden Heroes campaign.
- 5. That Bonner County encourages all who care for and support veterans and service members to extend that support to their caregivers.
- 6. That Bonner County shall designate a point of contact for our community, for citizens and organizations wanting to offer support and caregivers seeking that support.
- 7. That Bonner County uses the Elizabeth Dole Foundation's Military Caregiver Experience Map to understand the state of the military caregiver journey and use it as a tool to encourage community understanding and support.
- 8. That Bonner County shall work in concert with the Idaho State Society, Daughters of the American Revolution (ISSDAR), and in coordination with our local Veteran Service Organizations to execute these tasks, thereby ensuring Idaho's Military Caregivers are identified, acknowledged for their service, and supported wherever possible.
