Validation Legal Description for a portion of East Bottle Bay Road

Section 3, Township 56 North, Range 1 West, B.M.
Bonner County, Idaho

All that portion of the existing road right of way of East Bottle Bay Road, lying northerly of the north right of way of Bottle Bay Road and lying southerly of Lot 5 of the Plat of Shields Lakeshore Lots, recorded in Book 2 of Plats, Page 81 on May 3, 1961, said East Bottle Bay Road shown on Record of Survey Instrument No. 247930 recorded 1981 and as shown on Record of Survey Instrument No. 398199 recorded October 3, 1991, being a fifty foot (50') wide strip of land lying in the Northwest Quarter (NW1/4) of Section 3, Township 56 North, Range 1 West, Boise Meridian, Bonner County, Idaho, and being twenty-five (25) feet on each side of the following described centerline:

BEGINNING at the point of intersection of said centerline of East Bottle Bay Road with said north right of way of Bottle Bay Road, from which, the West Quarter Comer of said Section 3, marked with a 2-1/2" aluminum monument by PLS 9905, bears South 36°52'12" West a distance of 954.22 feet and from which the Southeast Corner of Lot 1 of JJL Estates, as recorded in Book 12 of Plats, Page 82, Instrument No. 913828 on October 31, 2017, marked with a 5/8" rebar, bears North 50°54'23" West a distance of 27.97 feet;

Thence along said centerline, the following six (6) courses:

- 1. North 22°36'39" East a distance of 192.51 feet to a point curvature to the left;
- Along said curve to the left an arc distance of 119.12 feet, having a radius of 402.46 feet, a delta angle of 16°57'30", the chord of which bears North 14°07'54" East a distance of 118.69 feet to a point of tangency;
- 3. North 05°39'08" East a distance of 212.33 feet to a point curvature to the left;
- Along said curve to the left an arc distance of 197.67 feet, having a radius of 528.99 feet, a delta angle of 21°24'36", the chord of which bears North 05°03'09" West a distance of 196.52 feet to point of tangency;
- 5. North 15°45'27" West a distance of 351.83 feet to a point curvature to the right;
- Along said curve to the right an arc distance of 153.34 feet, having a radius of 235.90 feet, a delta angle of 37°14'40", the chord of which bears North 02°51'53" East a distance of 150.66 feet to the south line of said Lot 5 of Shields Lakeshore Lots and the POINT OF TERMINUS.


