**WHEREAS,** the Technology department has FY2020 A funds in the amount of \$68,909.98 and D \$24,974.59 funds in the amount of from a recently vacated, position and;

**WHEREAS**, critical technology projects are in process but paused, the county will benefit by finishing projects by using subject matter experts from IT vendors, and;

**NOW, THEREFORE, BE IT RESOLVED** the Board of Commissioners of Bonner County, Idaho hereby authorize the Clerk to open the budget and transfer funds by increasing the 00115-8690 number by \$93,884.57 from \$40,000 to \$133,884.57 and decrease 00115-6060 by \$68,909.98 from \$516,526 to \$447,616.02, decrease 00115-6130 by \$5271.61 from \$43,177 to \$37,905.39, decrease 00115-6150 by \$11,475.12 from \$47,315 to \$35,839.88, and decrease 00115-6120 by \$8227.86 from \$56,301 to \$48,073.14.
