Luke Hixson Two Years expiring 1/21/22



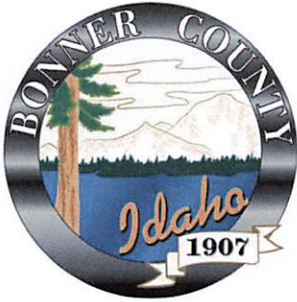
