WHEAREAS, on July 1, 2018, enactment of Senate Bill No. 1274 further amends Title 74 of Idaho Code; and

WHEAREAS, the Elected Officials of Bonner County recognize the requirement to appoint a custodian or custodians for all public records pursuant to Idaho Code 74-106 (16);

NOW, THEREFORE, BE IT RESOLVED that the attached list shall serve as the official list of public record custodian for the divisions and /or departments under each of the Elected Officials of the County.
