

WHEREAS, the purchase will be made by the GIS Department once the budget adjustment has been made; and

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby authorizes the Clerk to open the budget and increase line 00124-7860 Miscellaneous Expenses in the amount of \$15,178.00 from \$14,139.34 to \$29,317.34.

Adopted as a Resolution of the Board of Commissioners of Bonner County, Idaho on the 24th day of March, 2020.



Re: General Fund Budget Adjustment

Description: Idaho Code 31- 1605 and 31-4603 provide that in the event of any unforeseen contingency arising, which could not reasonably have been foreseen at the time of making the budget, the Board of County Commissioners, by unanimous vote thereof, to do a budget adjustment from the General Fund Account 00118-7860 to 00124-7860 The GIS Department has incurred additional expenses that were not originally budgeted for, such as equipment requirements to meet the increase in demand for services, leaving the office \$15,178 short for the duration of this fiscal year. Bonner County wants to properly fund the GIS Department budget through the end of FY20.
