

Re: The Fish and Wildlife Service received a grant for restoration activities in the Pack River Area in 2016. During this time, Bonner County has been working in cooperation with Fish and Wildlife and Bonner County Soil and Water District to accomplish these restoration activities. Bonner County is being reimbursed for labor costs associated with planting trees and willows as well as other maintenance costs for work completed last fall and spring in the amount of \$1,580.17. Due to this anticipated revenue, I would like to request the parks budget to be opened and line item 030-7860 Misc. Expenses be increased in this amount.
