GENERAL FUND STATUTORY RESERVE APPROPRIATION

WHEREAS, Idaho Code 31- 1605 and 31-4603 provide that in the event of any unforeseen contingency arising, which could not reasonably have been foreseen at the time of making the budget, the Board of County Commissioners, by unanimous vote thereof, shall have the right to make an appropriation from the statutory reserves to the office, department, service, agency or institution in which said contingency arises, in such amount shall be determined by Resolution of said Board, and;

WHEREAS, the Commissioner's Office has incurred more expenses that were originally budgeted for, with the addition of a new county employee being added to the FY20 A budget and the need to install new technology for meeting streaming stemming from the COVID-19 Pandemic. and;

WHEREAS, Bonner County wants to properly fund the Commissioner's Office budget through the end of FY20.


NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners of Bonner County, Idaho authorizes the Clerk to open the 2019 General Fund Statutory Reserve Budget and decrease line item 01120 -7860 (General Fund 5% Statutory Reserve) in the amount of \$47,820.74 and open the 2020 Commissioner's Office Budget and increase line item 00105-6080 by \$34,954, increase line item 00105-6130 by \$2,673.98, increase line item 00105-6120 by \$4,192.76, and increase line item 00105-9430 by \$6,000.

The foregoing was duly enacted as a Resolution of the Board of County Commissioners of Bonner County, Idaho, on the 7th day of July, 2020.
