Bonner County EMS Budget Adjustment - Unanticipated Revenues

WHEREAS, Idaho Code §31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes; and


WHEREAS, Bonner County EMS has received unexpected revenue in the amount of \$2,100.00 from The Rotary Club, Sandpoint Surgery Center and Sandpoint Property Management for an AED to be placed in the Sandpoint Center;


WHEREAS, it would be in the best interests of the EMS department to utilize these funds during the current fiscal year for an AED unit.


