**WHEREAS**, Bonner County Revised Code Section 12-122 provides for the creation of the Bonner County Planning & Zoning Commission, procedures for filling vacancies and terms of office thereon; and


**WHEREAS**, the Chair of the Board of County Commissioners has submitted to the Board the names of Brian Bailey, District 3, for reappointment; and Dave Frankenbach, At Large, for appointment to the Planning & Zoning Commission;

### Memorandum

Re: Appointment of Commissioners to Planning Commission

The terms for two Planning & Zoning Commission members expire September 30, 2020. Commissioner Brian Bailey submitted his name for consideration for reappointment to a full three-year term on the Planning Commission. Commissioner Trevor Kempton has advised he will not be seeking reappointment.

An advertisement was published in the Bonner Daily Bee and on social media, advising of the pending vacancies on the Planning & Zoning Commission. Several letters of interest were received.

State code (I.C. 67-6504) requires the Board Chairman to submit the names of the candidates for appointment, and for the majority of the Board to confirm the appointments. The Board chair advised he is interested in submitting Brian Bailey's name for reappointment and Dave Frankenbach's name for appointment to the Planning & Zoning Commission.

Brian Bailey represents Commissioner District #3. With the reappointment of Brian Bailey, there are two representatives from each of the districts and therefore Dave Frankenbach should be appointed as "At Large".
