WHEREAS, on July 14th, 2020, the BOCC approved a Road & Bridge Department contract with Poe Asphalt Paving, Inc., for \$569,547.00, funded through 002...8490 – Plant Mix Asphalt, to pave 1.5 miles of North Kootenai Road, which was begun in September; and

WHEREAS, The Commissioners approved a \$19,149.00 contract with C.E. Kramer, for constructing the Gypsy Bay Bridge on September 1st, 2020, funded through 002...8760 – Contracts-Roads, which was begun in September. Actual quantities for concrete and gravel increased from preliminary design bid to construction, as well as the County's request to lower and reset the footings, adding \$5,816.00; and

WHEREAS, with unforeseen delays the installation was not completed by end of FY20 and the projects have been completed in FY21;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Bonner County, Idaho hereby authorizes the Clerk to open the Road & Bridge FY21 budget and increase line item 002-8490 Plant Mix Asphalt by \$569,547.00 for asphalt paving and 002...8760 — Contracts-Roads by \$24,965.00 for bridge construction. The total carry over for the Road & Bridge budget shall be \$594,512.00.
