**Appoint** G. Bruce Hollett to the Bonner County Fair Board for a four-year term beginning on December 15, 2020 and ending on December 14, 2024.


**Re-Appoint** Eddie Gordon to the Bonner County Fair Board for a four-year term beginning on January 10, 2020 and ending on January 9, 2024.

The foregoing was duly enacted as a Resolution of the Board of County Commissioners of Bonner County, Idaho, on the 15th day of December 2020.




