**WHEREAS**, Bonner County EMS has received unexpected revenue in the amount of \$10,000.00 from the Idaho EMS Bureau for the purchase of a Lucas Mechanical CPR device


**WHEREAS**, it would be in the best interests of the EMS department to utilize these funds during the current fiscal year for the Lucas Mechanical CPR device.


