MEMORANDUM

To: Commissioners

Re: Designation of Kelso as a Mail Ballot Precinct for the March 2021 election only

Description: I.C. §34-308 Mail Ballot Precincts. We are able to designate a precinct as a Mail

Ballot Precinct if the registered electors are 140 or fewer. We have only 28 voters in our Kelso precinct who are qualified to vote in the March election (on the Lakeland School District Levy). I have asked the SOS if we are, as a result, able to declare Kelso a Mail Only Precinct for the March election ONLY, and they gave me permission. This will mean we don't have to staff (and pay) a polling place from 7am to 8:30pm on Election Day for the *possibility* of having 28 voters

come. (Only 6 votes were cast last time in August of 2019)

As a result, we will mail all 28 voters a ballot just like absentee ballots with the same safe guards and they will be returned just like all the other absentee ballots. They will all have the ability to vote.
