WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted to reflect the receipt of unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes, and;

WHEREAS, Bonner County Road & Bridge has received unexpected revenue in April in the amount of \$812,441.23 as a one time transportation supplemental appropriation from the State of Idaho that were not anticipated or budgeted for, and;

WHEREAS, it would be in the best interests of the Road and Bridge department to utilize these funds during the current fiscal year for road improvements in Bonner County; and

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Bonner County, Idaho hereby authorize the Clerk to open the Road and Bridge budget and schedule revenue by increasing the following line item: 002-8490 Plant Asphalt: Increase by \$812,441.23 from \$819,547.00 to \$1,631,988.23.

R & B 002 Budget Unanticipated Revenue - FY21 Idaho Supplemental Appropriation

Bonner County Road & Bridge has received unexpected revenue in the amount of \$812,441.23 that was not anticipated or budgeted for in FY21. The Legislature and the Governor approved a one time surplus distribution of transportation funds to local highway jurisdictions. This revenue was not anticipated or budgeted for, but will be applied to hot mix asphalt projects that are not currently in the FY21 Budget.
