First payment is for \$128,103.97 that Bonner County Road and Bridge has received. The second payment for \$128,103.96 will not be issued until after completion of the Heath Lake crossing closure. These payments were intended to cover the cost of the Heath Lake crossing project to Bonner County Road and Bridge.

WHEREAS, this first payment of unanticipated revenue could be used to purchase gravel and traction sand as well as help fund Capital heavy equipment needs.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Bonner County, Idaho hereby authorizes the Clerk to open the Road & Bridge FY21 budget and increase object lines 002-9520- Capital – Heavy equipment by \$70,103.96 and increase object line 002-8430-Crushed rock/Gravel by \$40,000.00; then increase object lines 002-8440 Sand- by \$18,000.00.

Bonner County entered into an agreement with BNSF on the Heath Lake crossing closure. This agreement was for two payments for a total combined of \$256,207.93 thus to be split into one payment of 128,103.97 That Bonner County has recently received. The second payment for the sum of \$128,103.96 will be paid upon completion of the project. These payments were to offset cost to the project to Bonner County. Road and Bridge would like to add this first payment of \$128,103.97 unanticipated revenue to our "B" and "C" Budgets.

We are proposing to increase Bonner County Road and Bridges "B" budget 002-8430-Crushed Rock/Gravel by \$40,000.00. We are also proposing to increase 002-8440 -Sand by \$18,000.00 We are proposing to increase Road and Bridges "C" Budget 002-9520 - Capital - Heavy Equipment \$70,103.97, for a total of \$128,103.97 of unanticipated revenue to the Road and Bridges "B" and "C" Budgets.

Road & Bridge requests the Commissioners authorize the Clerk to open the FY2021 budget and add unanticipated revenue to Road and Bridges "B" and "C" Budgets for a total increase of \$128,103.97.
